2. Minutes of the last AGM

3. Matters arising from minutes

JP asked if there had been any follow-up re recruiting a Vice-Chair

StW explained that he had approached member clubs via email but had not received a response.

Discussion took place about reviewing the positions of chair & vice chair.

StW deferred the matter for further consideration under AOB

4. Chair's Report

5. Treasurer's Report

SyW shared the report to be viewed on screen.

Discussion points

• CG questioned the cost of the web site

JP explained that the most recent bill for the website would be in this year's accounts.

• SyW noted the account listed Community Account and Business Account while the report referred to Current Account and Deposit Account.

JP clarified

- Community Account = Current Account
- Business Account = Deposit Account
- DW asked for further explanation regarding the banking situation.

JP reiterated the problems with the accounts explaining that it could take months to open a new account and access the missing funds.

So far contacts within Barclays have been unable to clarify how much was in the credit account but JP is confident said moneys will be refunded when the Dormant Account is retrieved.

• DW also asked if monies could be withdrawn from the Deposit Account.

JP said he is unable to make withdrawals either online or through the banking app.

- CG explained that club accounts were also difficult to manage with some other banks. He believed it might be to prevent money laundering.
- As per Treasured report JP proposed the opening of a new account with Nat West.

• It was unanimously agreed that JP should open a new with Nat West.

Subscriptions

Consideration was given with regard to subscriptions this year.

- Pre covid overheads where amounting to approx. £150 pa
- Income was approx. £250 pa
- Funds are quite healthy.

• No subscriptions will be collected this year
