2. Minutes of the last committee meetings

6. Chairs report

StW thanked the committee for their continued support in difficult circunstances

7. Treasurer's report

Treasurer John Peters shared the accounts visually. JP to send a copy of the account to SyW to include with the minutes of the meeting

CC identified a reference in the previous minutes relating to a charitable donation, in lieu of a fee to judge Chris Shore. CC asked if this has been paid. JP clarified that it had not as he hadn't been advised of said charity.

Action

- CC to email Chris Shore to establish his chosen charity.
- CC to inform JP so payment can be made.

Subscriptions

Due to the lack of competitions the committee considered a reduction in subscription from clubs. *Payment will be required in the new financial year*.

Considering the current finance position of the group the committee felt that an income of £175 would be adequate for the next round of subscriptions. This equates to £25 per club.

Decision

• The committee, unanimously agreed to £175 to be calculated on a pro-rata basis. *Action*

• JP to calculate a pro-rata payment per club based on the number of members.

SyW asked if, in the current circumstances, we should consider organising a standby judge. However, StW said that in the unfortunate event of said judge being unable to attend the event, providing he had already viewed and scored the images, we should be able to manage critique in house

9. Forthcoming competitions

- Regnum Print Competition
 - Autumn 2022

The competition is scheduled to be hosted by Chichester.

The last two print competitions were cancelled due to Covid 19. Steyning were expected to host the last competition – November '21 and Southwick – November '20.

Mike Warren from Steyning has been in contact to ask if they will be expected to run the next print competition.

The following points were discussed:

- SyW had already clarified with Southwick that they would not wish to host the coming competition as they are scheduled to host the next PDI competition Spring 2023.
- Any club organising a competition at a time other than their allocated year could put the rota out of sync.
- In March 2020 Chichester had indicated a reluctance to set a date for a print competition in Autumn 2022.

• Decision

• Chichester CC to be asked if they wish to host Regnum Print Competition 2022. If they respond in the negative Steyning will be approached.

Action

- SyW to contact Chichester to ascertain their position regarding hosting said competition.
- SyW to update Mike Warren from Steyning of the decision of the committee.
